TRIENNIAL AWARDS 2021

NOMINATION FORM

Please read these rules carefully before preparing and submitting your nomination.

1. Nominations may be made by anyone, whether or not they are connected with the project.
2. A '**project**' means a building or part of a building that demonstrates excellence in one of three crafts: brickwork, roof slating and tiling or wall and floor tiling. The project must have been completed in the **four years prior to 15 February 2021**.
3. The building or project must be located in the area bounded by the M25 motorway.
4. Nominations must include the following items collated in a wallet folder:
 - i) This **Nomination Form** completed with all available details where possible.
 - ii) A **supporting note** of not more than 100 words giving details of the project, the design parameters (if known) and the reasons why the nominator feels the project should be considered for an award.
 - iii) Up to **six photographs** giving an overall impression of the project and illustrating the part or parts which make it a contender for an award. Relevant drawings, though not required, may also be submitted.
 - iv) (If possible) **written agreement of the project owner** to its submission for an award.
5. If the project is short listed, the Judging Panel may require access to the building to inspect relevant features. The person making the nomination should be willing to arrange such access where possible.
6. Please note that by submitting a Nomination Form you are **consenting to the publication** of photographs and other descriptive material about the project, including on public areas of the Company's website and in press releases. Please also read the note below on the subject of data protection.

A note on data protection: The Worshipful Company of Tylers & Bricklayers (the "Company") is aware of its obligations under the General Data Protection Regulation (GDPR) and will treat personal data provided by you as being confidential and comply with all data protection legislation in respect of it. We will only use the personal information you provide to the Company on this Nomination Form for the purposes of assessing, short listing and judging the Triennial Awards 2021 where we have a lawful basis to do so. Personal data may be collected from the Nomination Form, from responses given to queries raised by us and from notes made by us during the assessment, short listing and judging process, including site visits.

If the project nominated by you is selected to receive a Triennial Award, the personal data provided by you may be used for the purpose of making the Award, including publication of details of the winning projects in a press release, brochure of award winners and/or on the Company's website. If the project nominated by you is not successful, we will retain Nomination Forms, including your personal data, for six months after the closing date for nominations to support enquiries relating to your nomination. Your legal rights in relation to data we hold about you, including your right to request access to your personal data, are included in the Privacy Policy on our website www.tylersandbricklayers.co.uk.
